### APPLICATION SUBMISSION DEADLINE

The application form, required documents, and official transcripts must be received by the deadline listed on the website to be considered for admission to the Program.

Acceptance/Rejection letters will be sent to applicants by the 3rd week after the deadline.

# ADMISSION REQUIREMENTS/ PROCESS

## PHASE I

1. The applicant must submit an online Application, along with a non-refundable \$100.00 Application Fee.
2. Applicant must be a Licensed Practical Nurse with a current license in good standing and qualified to practice nursing in the Commonwealth of Virginia.
3. Applicant must provide evidence of high school completion by submitting an official high school transcript, a GED Certificate, a Postsecondary degree transcript, or a transcript showing successful completion of at least 60 semester transferable credit hours.
4. Applicant must submit official college transcripts with required prerequisite courses. Applicant must complete the following prerequisite courses with a "C" or better from an Institution of Higher Learning accredited by an accrediting agency recognized by the U.S. Department of Education:
  - Anatomy & Physiology I
  - Anatomy & Physiology II
  - Microbiology
  - College Psychology
  - College Mathematics
  - College English Composition
  - Speech/Public Speaking/Communication
  - \*International Transcripts: Non-U.S. transcripts of secondary and/or post-secondary education must be evaluated by an evaluation agency to determine U.S. equivalency.
5. The applicant must take the HESI LPN to ADN Entrance Exam and achieve a score of "750" or higher. Applicants may take the Exam twice each admission cycle. In the event an applicant does not receive a score of 750 or higher after two attempts, he/she will no longer be considered for admission to the program. The applicant may apply to an LPN to RN Transition Program with a different start date.
6. Applicants must attend an admissions interview.
7. Pending the receipt and review of the above documents by the established time frame and once accepted, the applicant will be notified in writing.

## PHASE II

1. Applicants must successfully complete the Fundamental Nursing Skills and Concepts Validation Course with a score of 79.5% or higher. There is a \$1295 cost to take the course. Students make this payment out of pocket. Financial aid does not cover the cost of the Validation course.
2. Applicants must complete a criminal Background Check and Drug Test.
3. Applicants must complete and submit Physical Exam, required immunizations, and TB testing.
4. Applicants must submit an American Heart BLS CPR certificate

The Program consists of four terms. Students take one course at a time and must pass each course in order to proceed to the next course. A student passes a course with a grade of 79.5% or higher. Students receive an Associate's Degree upon graduating from the Program.

Standard College transitioned to a blended online/on-campus learning environment due to the COVID-19 pandemic. Course lectures in the LPN to RN Transition Program will begin online. Students return to campus to participate in the Skills Lab and to sit for mid-term and final exams. Students must have regular access to a computer with a camera and internet access in order to successfully participate in the program.

## **CLINICAL SCHEDULE**

Due to the competitive nature of clinical placement and to ensure appropriate and adequate clinical experiences, clinical sessions may be held on weekdays, weekends, and evenings. Clinical assignments are based on clinical agency availability as determined by the agency. Clinical sessions are held in Virginia, Maryland, and Washington D.C. Students must be flexible regarding clinical schedule.

## **COVID-19 Vaccine Policy**

## **RECOMMENDED STUDY TIME**

A basic rule for any degree is to spend the same number of hours studying per week as you are in class. Since you will be taking 16 hours of classes each week, you should be studying 16 hours per week at a minimum. Depending on the difficulty level of the course, may need to study more than 16 hours weekly.

## **RECOMMENDED HOURS OF WORK**

The LPN to RN Program is rigorous. It demands time and flexibility. The number of hours a student can work is dependent on the individual. We strongly recommend that students work no more than 32 hours a week.

## **HESI – PRE-ADMISSION TEST**

The HESI LPN to ADN entrance exam is a 75-item nursing exam for Licensed Practical nurses seeking entrance into the LPN to RN Transition program. Students are given up to 2 hours to take the Exam. Study Materials: NCLEX PN book or PN Course Textbooks
