   Educates the patient and family regarding pain management.
- Demonstrates knowledge of medications and their correct administration based on age of the patient and patient's clinical position.
- Follows the seven (7) medication rights and reduces the potential for medication errors.
- Performs all aspects of patient care in an environment that optimizes patient safety and reduces the likelihood of medical/health care errors.
- Functions as a team member demonstrating collaboration with, and responsibility to patient, physician, interdisciplinary team.
- Adheres to all HHA, payroll, billing and documentation policies and procedures.
- Participates in HHA's other mandated activities, as requested by Clinical Supervisor or Patient Care
- Supports and maintains a culture of safety and quality.
- Promotes patient/family education using various verbal and written communication techniques that



take into account the patient's/family's cultural, ethnic and/or personal needs or preferences.

- Collaborates with the patient/family to learn appropriate self-care techniques.
- Completes and submits necessary documentation in accordance with HHA policy and applicable regulations.
- Submits verification of completed visits in accordance with HHA policy.
